TRADEMARK ASSIGNMENT AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee, its successors and assigns, and Assignee has accepted, any and all of Assignor’s right, title and interest in and to the Trademarks, together with the right to sue and recover for, and the right to profits or damages due or accrued, arising out of or in connection with any and all past, present or future claims relating to the Trademarks, including, without limitation, infringements or dilution of or damage to the Trademarks or the associated goodwill; all common law, statutory and other rights therein; any and all trademark registrations and trademark applications corresponding to the Trademarks; and any and all goodwill of the business associated with the use of, or symbolized by, the Trademarks.

Assignor further agrees that, without further consideration, it will cause to be performed such other lawful acts, and to be executed such further assignments and other lawful documents, as Assignee may, from time to time, reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Trademarks. Assignor agrees to cooperate fully with Assignee to accomplish such recordation.
