RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of January 26, 2022, by JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, as Agent (the "Agent"), in favor of PUFFER-SWEIVEN LP, a Delaware limited partnership ("Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below), whether directly therein or by reference to another agreement.

WITNESSETH:

WHEREAS, Grantor and Agent are party to that certain Security Agreement, dated as of January 15, 2015 (the "Trademark Security Agreement"), which was duly recorded on January 28, 2015 at Reel 5448, Frame 0577 in the United States Patent and Trademark Office;

WHEREAS, Grantor granted the Agent, under the terms of the Trademark Security Agreement, a security interest in favor of the Agent, in and to all of its Trademark Collateral, including without limitation the trademarks listed in Schedule 1;

WHEREAS, Grantor has requested that the Agent release its continuing security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor; and

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Agent hereby releases the security interest in all of Grantor's right, title and interest in and to the Trademark Collateral, including the trademarks referred to in Schedule 1.


2. The Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademark Collateral and hereby terminates the Trademark Security Agreement.

The liens and security interests evidenced by the Trademark Security Agreement, and any other right, title or interest granted to the Agent in the trademarks set forth on Schedule 1 attached hereto is hereby terminated, cancelled and released, without representation or warranty, and the Agent hereby re-assigns, without representation or warranty, to the Grantor any right, title or interest it may have in or to any of the trademarks set forth on Schedule 1.

The Agent authorizes the recordation of this Release of Security Interest in Trademarks with the United States Patent and Trademark Office, at Grantor's expense.
