RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 3, 2022 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as Agent (the “Agent”), in favor of the grantor party identified on the signature page hereto (the “Grantor”).

WHEREAS, pursuant to that certain Security Agreement, dated as of May 12, 2016, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Agent, a lien on and security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Trademark Collateral Agreement, dated as of August 25, 2021 (the “Trademark Collateral Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Collateral Agreement was recorded with the United States Patent and Trademark Office on September 21, 2021 at Reel/Frame 7427/0353;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Collateral Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby absolutely, unconditionally and irrevocably releases, discharges, terminates and cancels all of its lien on and security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth Schedule A attached hereto, arising under the Security Agreement and/or the Trademark Collateral Agreement.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Collateral Agreement.


4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York State, without regard to conflicts of law or choice of law principles.

6. Successor and Assigns. This Release shall be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.
