**PARTIES:**

- (1) **THE INTERNATIONAL TOILETRY COMPANY INC** of 20283 State Road 7, Suite 300, Boca Raton, Florida 33498, USA ('ITCI').
- (2) **THE SOMERSET TOILETRY COMPANY LIMITED** of Upper Bristol Road, Clutton, Somerset, England, BS39 5TA, United Kingdom ('TSTC').

**BACKGROUND:**

- A ITCI is the owner of the trade mark listed in the Schedule ('Trade Mark').
- B ITCI has agreed to assign all its rights in and to the Trade Mark to TSTC in accordance with the provisions of this Agreement.

**AGREEMENT:**

**1. Assignment**

In consideration of the sum of £1 paid by TSTC to ITCI (receipt of which ITCI acknowledges), ITCI assigns with full title guarantee to TSTC absolutely the Trade Mark and all and any rights in and to the Trade Mark and any common law rights and all the goodwill attaching to the Trade Mark.

**2. Proceedings**

- 2.1 TSTC will have the right to bring proceedings against any third party in respect of the Trade Mark (including, without limitation, proceedings against any third party for past infringement of the Trade Mark or for passing off or for otherwise infringing the rights of ITCI in the Trade Mark).
- 2.2 ITCI agrees and undertakes to provide TSTC (at its cost and request) with all assistance with any proceedings which may be brought by or against TSTC against or by any third party in relation to the Trade Mark.

**3. Further Assurance**

ITCI will, at the cost and request of TSTC at any time and from time to time, execute such deeds or documents and do such acts or things as may be reasonably necessary or desirable to give effect to this Agreement.


**4. Law and Jurisdiction**
