DEED OF ASSIGNMENT

THIS ASSIGNMENT is made on January 29, 2022

BETWEEN

Weizhou Yu, a Chinese individual residing at FL 11th, Renhengzhidi Plaza, No. 1 Renmin Erduan South Street, Chengdu, Sichuan CHINA (hereinafter referred to as "the Assignor") of the one party;

AND

Zhongshan Taili Household Products Manufacturing Co., Ltd, a limited company organized and existing under the laws of KANGHUA ROAD, SHIQI DISTRICT, NO. 3 YIDONG STREET, ZHONGSHAN CITY, GUANGDONG, CHINA (hereinafter referred to as "the Assignee") of the other party.

WHEREAS the Assignor is the sole proprietor of the U.S. Trademark Registration No. 5,832,413 of the "TAILI" mark for certain products in International Classes 16 and 20 (the "TAILI MARK");

AND WHEREAS the Assignor has agreed to assign to the Assignee the TAILI MARK together with the goodwill of the business concerned in the goods and services for which the TAILI MARK is registered for and used and all rights therein for the consideration hereinafter appearing.

NOW THIS ASSIGNMENT WITNESSETH that in pursuance of the agreement and in consideration set forth in a separate Settlement Agreement and now paid by the Assignee to the Assignor. The assignor as beneficial owner hereby assigns and transfers unto the Assignee **THIS TAILI MARK** together with the goodwill of the business concerned in the goods and services for which the TAILI MARK is registered for and used **TO HOLD** the same unto the Assignee absolutely.

The Assignor hereby undertakes to execute all such documents and to take all such acts as may be necessary to perfect this assignment to the Assignee.
