## CORRECTIVE TRADEMARK ASSIGNMENT

This Corrective Trademark Assignment ("Assignment") is intended to replace the "Service Mark Assignment" executed on August 1, 2011, recorded at Reel/Frame 4530/0672, concerning an assignment of trademarks from Union Pacific Railroad Company to Chemlogix LLC. In that assignment, Chemlogix LLC was misidentified as a Delaware corporation as a result of a typographical error, when as shown by its name, it is a limited liability company. Chemlogix LLC did not exist as a Delaware corporation as of the relevant date, and was instead a limited liability company of Delaware.

WHEREAS, Union Pacific Railroad Company, a corporation of Delaware, (hereinafter referred to as the "ASSIGNOR"), having its principal offices at 1400 Douglas St., Omaha, Nebraska, 68179, as of August 1, 2011, was the owner of the service mark, BULK TAINER, and its associated Reg. No. 2,008,600 registered with the United States Patent and Trademark Office on October 15, 1996 for "transportation of bulk liquids by train and truck services" in International Class 39 ("Service Mark"), together with the goodwill of the business symbolized by the Service Mark; and

WHEREAS, Chemlogix LLC, a limited liability company of the State of Delaware (hereinafter referred to as the "ASSIGNEE"), having a current business address at 960 Harvest Drive, Building A, Suite 200, Blue Bell, PA 19422 (formerly located at 1777 Sentry Parkway West Abington Hall, Blue Bell, Pennsylvania, 19422), was and remains desirous of acquiring and confirming all of the right, title and interest of ASSIGNOR in, to and under the Service Mark, together with the goodwill of the business symbolized by the Service Mark, to be effective as of August 1, 2011;

NOW THEREFORE, be it known that for Ten Dollars (US\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, Assignor hereby confirms the assignment to Assignee of all of Assignor's right, title and interest in the United States in and to said Service Mark as of August 1,

2011, and hereby assigns, *nunc pro tunc*, effective as of August 1, 2011, all of Assignor's right, title and interest in the United States in and to said Service Mark, together with the goodwill of the business symbolized by said Service Mark, any future registrations of said Service Mark, all common law rights associated with said Service Mark, all causes of action and other rights that may be asserted under said Service Mark, the right to sue third parties for infringement of or improper activities regarding said Service Mark, and the right to enjoy all of the monetary benefits obtained as a result of any such litigation, the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.
