RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 11, 2022 (the “Effective Date”), is made by M&T Bank, in its capacity as Secured Party (the “Secured Party”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of June 13, 2017, by and among the Secured Party, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Loan and Security Agreement”), the Grantors granted to the Secured Party a security interest in and to certain collateral;

WHEREAS, pursuant to the Loan and Security Agreement, the Grantors executed and delivered a Notice of Grant of Security Interest in Trademarks, dated as of June 13, 2017 (the “Home Front Communications Trademark Security Agreement”) and a Notice of Grant of Security Interest in Trademarks, dated as of June 13, 2017 (the “Team Subject Matter Trademark Security Agreement” and together with the Home Front Communications Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Trademark Security Agreements, each of the Grantors granted to the Secured Party a continuing security interest in and to and continuing lien upon such Grantor’s trademark registrations and trademark applications set forth on Schedule A hereto, together with the goodwill associated therewith (collectively, the “Trademark Collateral”);

WHEREAS, the Home Front Communications Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 15, 2017 at Reel/Frame 6084/0485 and the Team Subject Matter Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 15, 2017 at Reel/Frame 6084/0489;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Loan and Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Secured Party, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to and Lien upon the Trademark Collateral, including the trademark registrations and applications set forth Schedule A attached hereto, arising under the Loan and Security Agreement and the Trademark Security Agreements. If and to the extent that the Secured Party has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Secured Party, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.


3. Termination. The Secured Party, without representation or warranty of any kind, terminates and cancels each Trademark Security Agreement.

4. Further Assurances. The Secured Party agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
