**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 17, 2022 (the “Effective Date”), is made by HPS INVESTMENT PARTNERS, LLC, in its capacity as administrative agent for the Secured Parties (in such capacity the “Administrative Agent”), in favor of CANARCHY CRAFT BREWERY COLLECTIVE LLC, a Colorado limited liability company (f/k/a OSKAR BLUES BREWERY, LLC, a Colorado liability company, and the successor-in-interest to each of CIGAR CITY BREWING LLC, a Florida limited liability company, UTAH BREWERS COOPERATIVE, L.C., a Utah limited liability company, and OBB PERRIN HOLDCO CORP., a Delaware corporation) (“CANarchy Brewery”), and SALT LAKE BREWING CO., L.C., a Utah limited liability company (“SLBC” and, together with CANarchy Brewery, the “Grantors” and each individually a “Grantor”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement dated as of July 8, 2016, by and among the Grantors, the other grantors party thereto and Administrative Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered a Trademark Security Agreement, dated as of July 8, 2016 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on July 14, 2016 at Reel/Frame 5834/0587 (with respect to Oskar Blues Brewery, LLC), at Reel/Frame 5834/0675 (with respect to SLBC) at Reel/Frame 5834/0707 (with respect to Cigar City Brewing, LLC) and at Reel/Frame 5836/0654 (with respect to OBB Perrin Holdco Corp.);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing first priority security interest in and lien upon (the “Security Interest”) all of such Grantor’s right, title and interest in and to the Trademarks, including, without limitation, the Trademarks listed on Schedule A hereto, all related goodwill, and all proceeds and products thereof (collectively, the “Trademark Collateral”); and

WHEREAS, the Grantors have requested that the Administrative Agent terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (iii) re-assigns to each Grantor any right, title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Administrative Agent and without representation or warranty of any kind.

Each Grantor, and any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.
