TRADEMARK ASSIGNMENT

WHEREAS, OLDCASTLE INFRASTRUCTURE, INC. f/k/a OLDCASTLE PRECAST, INC., a corporation formed in Washington, ("Assignor"), is the owner of the trademark and trademark registration in the form more fully described in Exhibit A hereto (the "Mark");

WHEREAS, Assignor desires to assign and SUREPODS, LLC, a limited liability company formed in Delaware having an address of 1450 Veterans Boulevard, c/o WND Ventures, LLC, Redwood City, California 94063, ("Assignee") desires to receive all of Assignor's right, title and interest in and to the Mark, together with the goodwill associated therewith;

WHEREAS, Assignor's affiliated company, Oldcastle Light Building Products, LLC, and Assignee's affiliated company, WND Ventures, LLC have executed that certain Membership Interest Purchase Agreement dated May 23, 2019, (the "MIPA") pursuant to which membership interest in and to Assignee's predecessor-in-interest, Oldcastle Surepods, LLC was transferred from Oldcastle Light Building Products, LLC to WND Ventures, LLC; and

WHEREAS, the parties to the MIPA together with Assignor and Assignee intended and desire that the Mark be included among the other assets owned by Oldcastle Surepods, LLC at the time of the transfer of the membership interest documented in the MIPA.

NOW THEREFORE, for the consideration of \$1.00 and as set forth in the MIPA, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, assigns and sets over unto Assignee, its successors and assigns, all of Assignor's entire right, title and interest in and to the Mark, together with the goodwill associated therewith, all common law rights related to the Mark, all rights of registration, renewal and extension, and the right to recover for damages and profits for past infringements thereof.


Assignor agrees to execute and deliver at the request of Assignee all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may request in order to vest all of Assignor's right, title, and interest in and to the Mark in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.


