RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of February 18, 2022, by CANADIAN IMPERIAL BANK OF COMMERCE (“**Bank**”) in favor of HGE HEALTH CARE SOLUTIONS, LLC, a Delaware limited liability company, with its principal place of business located at 1301 Virginia Drive, Suite 100, Fort Washington, VA 19034 (“**Grantor**”).

Recital


