RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of August 23, 2021, by METROPOLITAN PARTNERS GROUP ADMINISTRATION LLC (“**Secured Party**”) in favor of TILTING POINT MEDIA LLC, a Delaware limited liability company (“**Grantor**”).

Recitals

WHEREAS, Grantor executed that certain Intellectual Property Security Agreement, dated as of May 21, 2018 (the “**IP Security Agreement**”) and recorded with the U.S. Patent and Trademark Office (“**USPTO**”) on May 23, 2018 at Reel/Frame No. 6334/0896, pursuant to which Grantor granted to Secured Party a security interest in all of its right, title and interest in, to and under the Intellectual Property Collateral (as defined in the IP Security Agreements).

WHEREAS, Grantor has requested and Secured Party has agreed to release its security interest in the Intellectual Property Collateral and terminate the IP Security Agreement.

Agreement

Now, therefore, Secured Party agrees that it terminates and releases its security interest in the Intellectual Property Collateral, including the trademark registrations, and trademark applications set forth in **Exhibit A** attached hereto and incorporated herein by reference, and terminates the IP Security Agreement, and reassigns to Grantor, without warranty or recourse, all interest of Secured Party in the Intellectual Property Collateral.


