## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this “Trademark Security Agreement”), dated as of February 25, 2022, is made by PatCo, LLC, a Colorado limited liability company having an address at 14401 W. 65<sup>th</sup> Way, Unit B, Arvada, CO 80004 (herein referred to as the “Grantor”), in favor of Garfield Park, LLC, a Kansas limited liability company (“Lender”).

**WHEREAS**, the Grantor has entered into a Bridge Loan and Security Agreement, dated as of January 7, 2022 (said Bridge Loan and Security Agreement, as it may hereafter be amended or otherwise modified from time to time being the “Loan and Security Agreement”, the terms defined therein and not otherwise defined herein being used herein as therein defined), in favor of the Lender, acting for itself (in such capacity, the “Secured Party”); and

**WHEREAS**, pursuant to the Loan and Security Agreement, the Grantor has granted to the Secured Party a security interest in all right, title and interest of the Grantor in and to the Trademark Collateral (as defined below) to secure the payment and performance of the Obligations.

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor does hereby further confirm, and put on the public record:

Section 1. Grant of Security Interest in Trademarks. The Grantor hereby grants to the Secured Party a security interest and continuing lien on all of such Grantor’s right, title and interest in, to and under the following, in each case whether owned or existing or hereafter acquired or arising and wherever located (collectively, the “Trademark Collateral”):

- (i) all United States, State and foreign trademarks, service marks, certification marks, collective marks, trade names, corporate names, d/b/as, business names, fictitious business names, Internet domain names, trade styles, logos, other source or business identifiers, designs and general intangibles of a like nature and, with respect to any and all of the foregoing: (i) all registrations and applications therefor including, but not limited to, the registrations and applications referred to in Schedule 1 hereto (as such schedule may be amended or supplemented from time to time),
- (ii) the goodwill of the business symbolized thereby,
- (iii) all rights corresponding thereto throughout the world,
- (iv) all rights to sue for past, present and future infringement or dilution thereof or for any injury to goodwill,
- (v) all licenses, claims, damages, and proceeds of suit arising therefrom,

and

(vi) all payments and rights to payments arising out of the sale, lease, license assignment or other disposition thereof;

provided that the security interest granted under Section 1 hereof shall not attach to, and the term "Trademark Collateral" shall not include any Excluded Property.

Section 2. Loan and Security Agreement. The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to the Lender pursuant to the Loan and Security Agreement and the Grantor hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Trademark Collateral made and granted hereby are supplemental of, and more fully set forth in, the Loan and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any irreconcilable conflict between the terms of this Trademark Security Agreement and the terms of the Loan and Security Agreement, the terms of the Loan and Security Agreement shall control to the extent of the conflict.

Section 3. Governing Law. This Trademark Security Agreement shall be governed by the laws of the State of New York.

Section 4. Counterparts. This Trademark Security Agreement may be executed in counterparts, each of which shall constitute an original, but all of which when taken together shall constitute a single contract. This Trademark Security Agreement shall become effective when the Lender has received counterparts bearing the signatures of all parties hereto. Delivery of a signature page of this Trademark Security Agreement by telecopy or other electronic means shall be effective as delivery of a manually executed counterpart of such Trademark Security Agreement.
