

## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of February 18, 2022 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as Collateral Agent (in such capacity, the "Collateral Agent"), in favor of the Grantors (hereinafter defined below), as follows:

### WITNESSETH

WHEREAS, pursuant to that certain Security Agreement between Collateral Agent and Grantors, dated as of November 20, 2017 (as amended, supplemented, enjoined amended and restated or otherwise modified, the "Security Agreement"), the Grantors granted to the Collateral Agent a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, Collateral Agent and Grantors entered into that certain Grant of Security Interest in Trademarks, dated as of November 20, 2017, (the "<u>Trademark Security Agreement</u>"), which was recorded with the United States Patent and Trademark Office on December 1, 2017 at Reel 6218, Frame 0555;

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.
- 2. <u>Release</u>. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, cancels and terminates all of its security interest in and continuing lien on Grantors' trademarks and trademark applications, including, without limitation, the trademarks listed on <u>Schedule A</u> attached hereto, and hereby re-assigns, re-transfers and re-conveys to Grantors any and all right, title or interest the Collateral Agent may have in and to Grantors' trademarks and trademark applications, together with all of the goodwill associated therewith.
- 3. <u>Further Assurances</u>. Collateral Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as Grantors may reasonably request, at Grantors' cost and expense, in order to perfect, confirm or evidence such release.
- 4. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
