**CONFIRMATION OF RELEASE AND DISCHARGE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

RECITALS:

- A. LIFESPEAK INC. (the “**Grantor**”) is the owner of the trademark applications and registrations set forth in Exhibit A (collectively, the “**Trademarks**”).
- B. The Grantor entered into an intellectual property security agreement, dated as of March 31, 2021, as amended, restated, amended and restated, supplemented or otherwise modified, the “**IP Security Agreement**” in favour of CANADIAN IMPERIAL BANK OF COMMERCE, as administrative agent for certain lenders (the “**Agent**”) under which the Grantor granted to the Agent, a security interest in the Trademarks, as security for its obligations under a certain credit agreement.

NOW THEREFORE for good and valuable consideration (the receipt and sufficiency of which are hereby acknowledged), the Agent hereby irrevocably and unconditionally releases and discharges to and in favour of the Grantor and its successors and assigns each and every security interest, lien, mortgage, charge, pledge, assignment and other encumbrance (collectively, “**Liens**”) created under each and every mortgage, charge or security agreement made by the Grantor in favour of the Agent over the Trademarks and the Agent hereby authorizes the Grantor and its solicitors and agents to discharge all registrations of such Liens made against the Trademarks.
