obtain trademark registrations in respect of the Trademarks, to prosecute any applications to register the Trademarks, to contest any oppositions affecting the Trademarks and to enforce such rights in any country, and further including any goodwill and common law rights in the Trademarks as Assignor may have.

FURTHER, Assignor agrees that, upon request and without further compensation, but at no expense to Assignor, it and its legal representative(s) and assigns will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, sustaining, reissuing or enforcing any trademark rights based on said Trademarks, and for perfecting, recording or maintaining the title of Assignee, its successors and assigns, to said Trademarks.

FURTHER, Assignor agrees to provide, upon request, copies of all documents pertaining to the conception, development, or use outside of Canada, of any of the Intellectual Property.


