Pursuant to Title 8, Section 251(c) of the Delaware General Corporation Law (the “DGCL”), the undersigned corporation executed the following Certificate of Merger.

1. The name and state of each of the constituent corporations of the merger (collectively, the “Constituent Corporations”) are as follows:

2. An Agreement and Plan of Merger (the “Merger Agreement”), dated as of February 18, 2020, by and among LendingClub Corporation, a Delaware corporation, SC Sub I, Inc., a Delaware corporation and Radius Bancorp Inc., a Delaware corporation, has been approved, adopted, executed and acknowledged by each of the Constituent Corporations in accordance with Section 251(c) of the DGCL (and by the written consent of each of the Constituent Corporations’ stockholder(s) in accordance with Section 228 of the DGCL).

3. The surviving corporation shall be LendingClub Corporation.

4. By virtue of the merger, the Certificate of Incorporation of the surviving corporation shall be the existing Restated Certificate of Incorporation (as amended by the Certificate of Amendment dated July 2, 2019) of LendingClub Corporation with no amendments.

5. The executed Merger Agreement is on file at 595 Market Street, Suite 200, San Francisco, CA 94105, the place of business of the surviving corporation.

6. A copy of the Merger Agreement will be furnished by the surviving corporation on request, without cost, to any stockholder of the Constituent Corporations.

7. This merger shall become effective at 12:02 a.m., Eastern Standard Time, on February 1, 2021.
