RELEASE OF SECURITY INTEREST
IN TRADEMARKS

Pursuant to the Security Agreement, the Grantor granted to the Collateral Agent, for the benefit of the secured parties referred to therein, a security interest in and to all of the Grantor’s right, title and interest in the Grantor’s trademarks, service marks, and trade names, trademark and service mark registrations, and applications thereof, including, without limitation, those specific trademark registrations and applications listed on Exhibit A attached hereto (the “Released Trademarks”), and the goodwill associated therewith.

The Security Agreement was recorded on March 10, 2017, at Reel/Frame 6029/0789 in the United States Patent and Trademark Office.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby releases, terminates and discharges its security interest in and to the Released Trademarks and the goodwill associated therewith, without representation or warranty of any kind, express or implied.
