## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) is entered into as of February 18, 2022, by FREEDOM JN LLC, a Delaware limited liability company (“**Debtor**”), in favor of AEG PRESENTS LLC, a Delaware limited liability company (“**Creditor**”).

### RECITALS:

A. Debtor and Creditor are parties to that certain Inducement, Guarantee Agreement and Security Agreement of even date herewith (as such may be amended and/or restated from time to time, the “**Security Agreement**”). Capitalized terms not otherwise defined herein shall have such meanings as set forth in the Security Agreement.

B. Debtor wishes to execute this Agreement to supplement the terms of the Security Agreement for recording with the United States Patent and Trademark Office.

### AGREEMENTS:

**NOW THEREFORE**, in consideration of the foregoing and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged by Debtor, and to induce the Creditor to enter into the Security Agreement, Debtor hereby agrees as follows:

1. Security Interest in Trademarks. As security for the Obligations, Debtor hereby grants to Bank a security interest in all Debtor’s present and future rights and interest in the trademarks identified on Schedule 1 attached hereto, together with all goodwill associated therewith.

2. Supplement to Security Agreement. This Agreement is executed to supplement and further evidence the security interest granted to Creditor under the Security Agreement. The rights and remedies of Creditor with respect to the security interest granted herein are in addition to those set forth in the Security Agreement, and those which are now or hereafter available to Creditor as a matter of law or equity.

3. Signature. Agrees that this Agreement may be executed in wet ink or via DocuSign, each of which shall be deemed an original; and that PDF and facsimile copies or photocopies of a signature to this Agreement shall be as valid as an original.

4. Recordation. Debtor authorizes and requests the United States Patent and Trademark Office to record this Agreement.
