**TRADEMARK ASSIGNMENT**

2. Cooperation in Transferring Trademarks. Assignor agrees to cooperate with Assignee and to follow Assignee's reasonable instructions in order to effectuate the transfer of the Trademark registrations in a timely manner with the United States Patent and Trademark Office, if any such steps should be necessary.
