## RELEASE OF SECURITY AGREEMENT

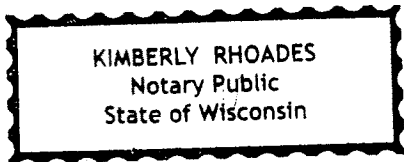



