**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 7, 2022 (“Release”), is made by Wells Fargo Bank, N.A., as Administrative Agent (“Administrative Agent”) in favor of Mandarin Holdings, LP, a Delaware limited partnership (“Borrower”).

WHEREAS, pursuant to that certain Security Agreement dated as of March 2, 2007 (as amended, modified, supplemented, or restated from time to time, the “Security Agreement”) by and among the Borrower, Administrative Agent, and others party thereto, and the Intellectual Property Security Agreement and License dated as of March 2, 2007 by and among the Borrower and Administrative Agent (“IP Security Agreement”), Borrower granted a security interest to the Administrative Agent, for the benefit of the Secured Parties, in all of the Borrower’s present and future right, title and interest in and to the TM Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on March 3, 2007 at Reel 3492 Frame 0512.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Borrower agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of the Borrower’s right, title and interest in and to the TM Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or IP Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Borrower’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.


