


2. Recordation and Further Actions. Workgroups DaVinci, Inc. hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Aquent LLC. Following the date hereof, upon Aquent LLC's reasonable request, Workgroups DaVinci, Inc. shall take such steps and actions, and provide such cooperation and assistance to Aquent LLC and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths,

exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the trademarks listed above to Aquent LLC, or any assignee or successor thereto.
