ASSIGNMENT OF TRADEMARKS

This assignment is made pursuant to terms of the Agreement.

Assignor hereby irrevocably appoints Assignee as its attorney-in-fact coupled with an interest to act in Assignor's name, place and stead to execute, deliver and record any documents or instruments of assignment or otherwise required in any country in which any of the Trademarks or Trademark Applications are pending or issued, or in which Assignee desires to seek protection for the Trademarks or Trademark Applications. Assignor hereby represents and warrants that it has not previously assigned, transferred, pledged, liened or otherwise encumbered any of the Trademarks or Trademark Applications or taken any other action which would conflict with this Assignment.
