United States Patent and Trademark Office

Ladies and Gentlemen:

Please be advised that (a) pursuant to the Security Agreement dated as of June 15, 2018 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the “Security Agreement”), by and among the Obligors party thereto (each an “Obligor” and collectively, the “Obligors”) and BMO HARRIS BANK N.A., as Administrative Agent (the “Administrative Agent”) for the secured parties referenced therein (the “Secured Parties”), the undersigned Obligors have granted a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on **Schedule 1** attached hereto, including the goodwill symbolized thereby (but excluding any “intent to use” Trademark applications for which a statement of use has not been filed, but only until such statement is filed) (the “Trademarks”) to the Administrative Agent for the ratable benefit of the Secured Parties and (b) the undersigned hereby grant to the Administrative Agent, for the ratable benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of such Obligors in and to the Trademarks.



Each undersigned Obligor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Administrative Agent with respect to the Trademark collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this notice and the terms of the Security Agreement, the terms of the Security Agreement shall govern.




