ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT

This **ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT** (this “**Assignment**”), dated as of March 16, 2022, is by **WHITE OAK GLOBAL ADVISORS, LLC** (“**White Oak**”), acting in its capacity as the resigning administrative agent (in such capacity, the “**Resigning Agent**”) and **HSBC BANK USA, NATIONAL ASSOCIATION**, acting in its capacity as the successor administrative agent (in such capacity, the “**Successor Agent**”).

RECITALS:

WHEREAS, Soroc Data Services Limited, as “**Grantor**”, and Resigning Agent are parties to the trademark security agreement dated as of December 21, 2020 and recorded with the United States Patent and Trademark Office at Reel 7141, Frame 0858 (as amended, restated, supplemented or otherwise modified from time to time, collectively, the “**Trademark Security Agreement**”) covering certain trademarks set forth on Exhibits A; and

WHEREAS, pursuant to that certain second amendment to loan agreement dated as of January 18, 2022, which amends the loan agreement dated December 21, 2020 (as amended by a first amendment to loan agreement dated as of March 3, 2021), by and among *inter alios*, the Resigning Agent and the Successor Agent (the “**Second Amendment**”), the Resigning Agent has resigned as administrative agent (including, without limitation, as collateral agent) under the Loan Documents and the Successor Agent has accepted its appointment as the administrative agent (including, without limitation, as collateral agent) under the Loan Documents, and the Resigning Agent has assigned to the Successor Agent all rights, powers, trusts and Liens granted to the Resigning Agent by the Borrowers and the Guarantors under the Trademark Security Agreement, among other Loan Documents.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Resigning Agent confirms, acknowledges and agrees that it has assigned, and to the extent it has not assigned, hereby assigns to the Successor Agent and its successors and assigns, all of its rights, powers, trusts and Liens granted to it by the Borrowers and the Guarantors under the Trademark Security Agreement.

Capitalized terms used and not otherwise defined herein have the meanings provided for such terms in the Second Amendment.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.


