NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of April 3, 2022, is made by JPMorgan Chase Bank, N.A., in its capacity as Administrative Agent (referred to herein as the “Agent”), in favor of Gianni Versace S.R.L., an Italian limited liability company (the “Company”).

W I T N E S S E T H:

WHEREAS, reference is made to that certain Intellectual Property Pledge and Security Agreement, dated as of September 18, 2020 (the “Security Agreement”), among the Company, the Agent and other parties thereto, pursuant to which the Company granted to the Agent for the benefit of the Secured Parties a security interest in certain intellectual property, including trademarks;

WHEREAS, in connection with the Security Agreement, the Company executed and delivered (i) the Trademark Security Agreement, dated as of September 18, 2020, in favor of the Agent (the “Trademark Security Agreement”), and (ii) Supplement No. 2 to the Trademark Security Agreement, dated as of December 8, 2021, in favor of the Agent (the “Trademark Security Agreement Supplement” and, together with the Trademark Security Agreement, the “Trademark Security Agreements”);

WHEREAS, pursuant to the Trademark Security Agreements, the Company pledged and granted to the Agent, on behalf of and for the benefit of the Secured Parties, a security interest in all of its intellectual property, including but not limited to the trademarks, service marks and trademark and service mark registrations and applications set forth on Schedule A attached hereto, together with the goodwill of the business symbolized thereby (the “Released Trademarks”); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on September 18, 2020 at Reel/Frame No. 7056/0772, and the Trademark Security Agreement Supplement was recorded with the USPTO on December 21, 2021 at Reel/Frame No. 7537/0962.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement, the Security Agreement or the Trademark Security Agreements, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Trademark Security Agreements).

SECTION 2. Release of Security Interest. The Agent, without any recourse, representation or warranty, does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, the Released Trademarks.

SECTION 3. Termination. The Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreements.

SECTION 4. Further Assurances. The Agent hereby authorizes the Company or the Company's authorized representative, at the Company's sole cost and expense, to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Agent in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Agent hereby further agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or its agents or designees) reasonably requests (at the Company's sole cost and expense) in order to effect the intents and purposes of this Release.

SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York.

SECTION 6. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
