WHEREAS, ROBLY DIGITAL MARKETING, LLC, a New Jersey limited liability company ("Robly" and together with TGAPC, collectively, the "Grantors" and each, a "Grantor"), and Administrative Agent were parties to that certain Trademark Security Agreement dated as of March 15, 2021 (the "Robly Security Agreement" and together with the TGAPC Security Agreement, collectively, the "Security Agreements" and each, a "Security Agreement") pursuant to which Robly granted a security interest to Administrative Agent in certain Trademarks and Trademark Collateral as security for certain obligations owing by Robly to Administrative Agent, including the Trademarks set forth on Schedule 2 hereto:

WHEREAS, the Robly Security Agreement was recorded with United States Patent and Trademark Office on March 16, 2021, at Reel 7221, Frame 0792; and

into in connection therewith and damages and payments for past or future infringements, dilutions or other violations thereof, (d) the right to sue for past, present and future infringements, dilutions or other violations thereof (e) the goodwill of the applicable Grantor's business symbolized by the foregoing and connected therewith and (f) all of the applicable Grantor's rights corresponding to the foregoing throughout the world; and (iii) reassigns, grants and conveys to the applicable Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent's right, title and interest in and to the Trademarks and the Trademark Collateral. Administrative Agent authorizes the recordation of this Trademark Release and Reassignment with the United States Patent and Trademark Office.
