## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK APPLICATION ASSIGNMENT AGREEMENT (this "Agreement") is made and entered into as of this 13 day of April, 2022, by and between:

Assignor shall take such further actions and execute such documents as Assignee may reasonably request from time to time to effect or confirm this assignment to Assignee of the Trademark, and to file, prosecute, and enforce the Trademark. In the event that Assignee is unable for any reason whatsoever, after reasonable inquiry, to secure Assignor's signature on any document in furtherance of the foregoing, Assignor hereby appoints Assignee's officers as Assignor's attorneys-in-fact with full power of substitution to act for, on behalf of, and instead of Assignor to execute and file any such document and to do all other lawfully permitted acts, solely to further the purposes hereof, and with the same legal force and effect as if executed by Assignor

This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract.

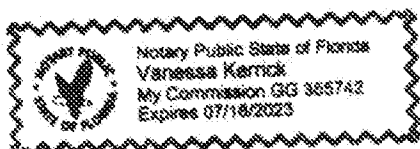
