1. Assignment. Assignor hereby grants, assigns and conveys to Assignee all of its right, title, and interest in and to the Registered Trademark, together with the goodwill of the business symbolized by the Trademarks. Assignee hereby accepts the Assignment of the Registered Trademark as described herein.

2. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged or delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment.

3. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.


