TRADEMARK RELEASE AND REASSIGNMENT

28 THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 28, 2022, by ATLANTIC UNION BANK, as Administrative Agent for the Lenders ("Administrative Agent").

WITNESSETH:

WHEREAS, Administrative Agent and WAHOO DOCKS, LLC, a Delaware limited liability company ("Grantor"), were parties to that certain Third Amended and Restated Patent and Trademark Security Agreement, dated as of November 3, 2021 (the "Agreement"; all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), and pursuant to which Grantor granted a security interest to Administrative Agent in the Trademark Collateral, including the Trademarks set forth on Schedule I hereto; and

WHEREAS, the Agreement was recorded by the United States Patent and Trademark Office ("USPTO") on November 4, 2021, at Reel 007483, Frame 0855;

WHEREAS, Grantor has requested that Administrative Agent release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, Administrative Agent has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral, including the following:

(a) all of its trademarks and rights in and to exclusive intellectual property licenses with respect to trademarks to which it is a party including those trademarks referred to on Schedule I hereto;

(b) all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations of and amendments to the foregoing; and


(c) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement of any trademark or any trademark licensed under any intellectual property license or (ii) right to receive license fees, royalties, and other compensation with respect to any of the foregoing.

2. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest (if any) in and to the Trademark Collateral.
