RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of May 19, 2022 (the “Effective Date”), is made by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the “Agent”), in favor of the grantors identified on the signature page hereto (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to (i) that certain Security Agreement, dated as of July 23, 2018, by and among the Agent, the applicable Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), (ii) that certain English law Security Agreement, dated as of July 23, 2018, by and among the Agent, the applicable Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “UK Debenture”) and (iii) that certain Joinder to the Pledge and Security Agreement, dated as of October 1, 2020, by and among the Agent, the applicable Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement Joinder”, and together with the Security Agreement and the UK Debenture, the “Collateral Agreements”), each Grantor granted to the Agent, in its capacity as administrative agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Collateral Agreements, the applicable Grantors executed and delivered for recordal with the United States Patent and Trademark Office (i) a Trademark Security Agreement, dated as of July 23, 2018 (the “2018 Trademark Security Agreement”), and (ii) a Trademark Security Agreement, dated as of October 1, 2020 (the “2020 Trademark Security Agreement”, and together with the 2018 Trademark Security Agreement, the “Trademark Security Agreements”);

WHEREAS, the (i) 2018 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 23, 2018 at Reel/Frame 6388/0555 and (ii) 2020 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 2, 2020 at Reel/Frame 7086/0633;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreements or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth on Schedule I attached hereto, arising under the Collateral Agreements and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably


requested by such Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.


