Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, as amended (the “**DLLCA**”), Training the Street LLC, a Delaware Limited Liability Company, in connection with the merger of Training The Street, Inc., a New Jersey corporation, with and into Training The Street LLC (the “**Merger**”), hereby certifies as follows:

**FIRST:** The name of the surviving Limited Liability Company is Training The Street LLC, a Delaware limited liability company (the “**Company**”).

**SECOND:** The name of the Corporation being merged into the Company is Training The Street, Inc., a New Jersey Corporation (the “**Merger Sub**”).

**THIRD:** The Agreement and Plan of Merger, dated June 2, 2021, by and between the Company and the Merger Sub (the “**Plan of Merger**”), setting forth the terms and conditions of the Merger and to be effective as of June 2, 2021, has been approved, adopted, certified, executed and acknowledged by each of the Company and the Merger Sub.

**FIFTH:** The Certificate of Formation of the Company, as in effect immediately prior to the effectiveness of the Merger, shall, upon the effectiveness of the Merger, be the Certificate of Formation of the Surviving Company.

**SIXTH:** The Merger shall be effective at such time as this Certificate of Merger is duly filed with the Secretary of State of the State of Delaware in accordance with the DLLCA.

**SEVENTH:** An executed copy of the Plan of Merger is on file with the Surviving Company at its place of business with an address at: 275 Madison Ave, #1201, New York, NY 10016.

**EIGHTH:** An executed copy of the Plan of Merger will be furnished by the Surviving Company, on request and without cost, to any member of the Company or any stockholder of the Merger Sub.
