Release of Security Interest in Trademarks

This Release of Security Interest in Trademarks, dated as of **May 2, 2022** (the "Release"), is made by **Credit Suisse AG, Cayman Islands Branch**, as collateral agent (in such capacity, the "Collateral Agent") in favor of **PSC Custom, LLC**, a **Texas limited liability company** (the "Grantor").

WHEREAS, by (i) that certain Term Loan Credit Agreement, dated as of **November 1, 2018** (as amended, restated, or modified from time to time, the "Credit Agreement"), (ii) that certain Security Agreement, dated as of **November 1, 2018** (as amended, restated, or modified from time to time, the "Security Agreement"), and (iii) that certain related Intellectual Property Security Agreement, dated as of **November 1, 2018** in favor of Collateral Agent (as amended, restated, or modified from time to time, the "IP Security Agreement"; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement, Security Agreement, or IP Security Agreement, as applicable), which IP Security Agreement was recorded with the United States Patent and Trademark Office on **November 2, 2018** at Reel **6473** Frame **0846**, the Grantor granted to Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor's right, title and interest in, to and under the Collateral (as defined in the IP Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantor desires Collateral Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantor (as defined in the IP Security Agreement), including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantor (as defined in the IP Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Collateral.

The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


