**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of May 24, 2022, is made by **MS PRIVATE CREDIT ADMINISTRATIVE SERVICES LLC**, as grantee (the "Grantee"), under the Security Agreement (as defined below) referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement (as defined below) or the Security Agreement, as applicable).

**WHEREAS**, in connection with that certain Credit Agreement, dated as of August 27, 2021 (as the same has since been amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among, *inter alios*, Vehlo Purchaser, LLC, a Delaware limited liability company (the "Borrower"), Vehlo Intermediate, LP, a Delaware limited partnership, ("Holdings"), the Lenders from time to time party thereto, and Grantee, as Administrative Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Borrowers;

**WHEREAS**, the Borrower, Holdings, and each of the other Grantors from time to time party thereto entered into that certain Pledge and Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), dated as of August 27, 2021 in favor of the Administrative Agent;

**WHEREAS**, pursuant to the Security Agreement and those agreements described on Annex I attached hereto (collectively, the "IP Security Agreements"), the Grantors granted security interests to the Grantee in certain intellectual property owned by the Grantors (the "IP Collateral"); and

**WHEREAS**, the IP Security Agreements were recorded in the United States Patent and Trademark Office or the United States Copyright Office, as applicable, on the dates and on the reels/frames or volume/document no., as applicable, set forth on Annex I attached hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby irrevocably **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in the IP Collateral, and the Grantee hereby reassigns any and all such right, title and interest (if any) that the Grantee may have in, to and under the IP Collateral to the relevant Grantor.


This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


