**RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (“Release”), effective as of May 31, 2022, is made by ALTER DOMUS (US) LLC, acting in its capacity as collateral agent (in such capacity, the “Collateral Agent”) under that certain Grant of Security Interest in Trademark Rights, dated as of November 13, 2020 (the “Trademark Security Agreement”), made by B.V. KONINKLIJKE NEDERLANDSCHE GLASFABRIEK LEERDAM, a Netherlands private company with limited liability, located at Lingedijk 8 4142LD Leerdam, The Netherlands (the “Company”) in favor of the Collateral Agent. Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Trademark Security Agreement.

W I T N E S S E T H:

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on November 16, 2020 at Reel 7107, Frame 0780, the Company granted to the Collateral Agent a continuing security interest in all of the Company’s right, title and interest in, to and under its owned or thereafter acquired Trademarks, including, but not limited to, those set forth on the attached Schedule A (the “Trademark Collateral”);

WHEREAS, the Company has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) discharge and release its security interest in the Released Collateral, and (c) reassign any and all rights, title and interest it has in the Released Collateral to the Company. The Collateral Agent agrees to make filings with the United States Patent and Trademark Office and take further actions, in each case as reasonably requested by the Company and at the sole expense of the Company, to evidence the release and termination of the Collateral Agent’s security interests in the Released Collateral.


THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE DEBTOR’S AND THE COLLATERAL AGENT’S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
