RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of June 1, 2022 (“Effective Date”) by JPMorgan Chase Bank, N.A., a national banking association, with its principal office at 560 Mission St., Floor 04, San Francisco, California, 94105 (“Grantee”), in favor of Bellami Hair, LLC, a Delaware limited liability company, with its principal office at 21123 Nordhoff St, Chatsworth, California 91311 (“Grantor”). Capitalized terms used but not defined herein shall have the meaning set forth in the Intellectual Property Security Agreement (as defined below).

WHEREAS, pursuant to the terms of that certain Intellectual Property Security Agreement by and between Grantor and Grantee dated June 29, 2021 (the “Intellectual Property Security Agreement”), Grantor granted to Grantee a security interest in and to all of Grantor’s right, title and interest in, to, and under the Intellectual Property Collateral, including any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Schedule A attached hereto (collectively, the “Trademarks”);

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on June 29, 2021, at Reel 7367, Frame 0281; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Intellectual Property Security Agreement, and hereby terminates, cancels, and releases any and all security interests it has against the Intellectual Property Collateral, including the Trademarks.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks and; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedule A, in any jurisdiction throughout the world.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), as reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
