RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (“**Release**”) is made as of May 31, 2022, by CANADIAN IMPERIAL BANK OF COMMERCE (“**Bank**”) in favor of MAYSTREET INC., a Delaware corporation (“**Grantor**”) with its principal place of business located at 135 W. 26th Street, 2nd Floor, New York, NY 10001.

Recital

WHEREAS, Grantor granted to Bank a security interest in the patents and trademarks described on Exhibits A and B attached hereto (collectively, the “**Intellectual Property**”) under an Intellectual Property Security Agreement dated as of February 4, 2021 (the “**IP Security Agreement**”) and recorded with the U.S. Patent and Trademark Office as set forth on Exhibits A and B.

WHEREAS, Grantor has requested and Bank has agreed to release its security interest in the Intellectual Property and terminate the IP Security Agreement.

Agreement

Now, therefore, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of Grantor secured by the Intellectual Property, pursuant to the IP Security Agreement, the receipt and sufficiency of which are hereby acknowledged, Bank hereby agrees as follows:

1. Bank hereby terminates, discharges and releases its security interest or other interests it may otherwise have in the Intellectual Property, terminates the IP Security Agreement and hereby reassigns to Grantor all right, title and interest of Bank in or to the Intellectual Property.
2. Bank authorizes and requests that the United States Commissioner for Patents record this Release.
3. This Release is governed by the laws of the State of New York without regard to principles of conflicts of law. This Release may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement.
4. This Release has been entered into in conjunction with the provisions of the payoff letter, by and between the parties, dated May 26, 2022. In the event that any provisions of this Release are in conflict with the payoff letter, the provisions of the payoff letter shall govern.


