ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property, dated as of May 6, 2022 (as hereinafter amended, modified or supplemented, this “IP Assignment”), is entered into by and between Impro, Inc., a Massachusetts corporation (“Assignor”), and Attain Juran LLC, a Delaware limited liability company (“Assignee”) (each a “Party” and together the “Parties”).

RECITALS

WHEREAS, Assignor, Assignee, Juran Institute, Inc., a Delaware corporation, Joseph A. Defeo an individual, and Joseph M. Defeo, an individual, are parties to that certain Asset Purchase Agreement, dated as of the date hereof (the “Agreement”);

WHEREAS, pursuant to the Agreement, Assignor agreed to sell, convey, assign, transfer and deliver to Assignee all of its rights, title, and interests in, to, and under, certain assets of Assignor comprising the Purchased IP (such Purchased IP, the “Respective IP Assets”), including all goodwill associated therewith; and

WHEREAS, this IP Assignment is made pursuant to, and in consideration of, the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

AGREEMENT

1. Capitalized Terms. Any capitalized term used but not defined herein shall have the meaning set forth in the Agreement.

2. Assignment. Assignor hereby sells, conveys, assigns, transfers, and delivers to Assignee, free and clear of all Liens, all right, title, and interest in, to, and under the Respective IP Assets. The Respective IP Assets consist of the following:

(a) Patents. All right, title, and interest in, to, and under the Respective IP Assets that comprise, consist of, or otherwise constitute any patents, including, without limitation, the following: (i) United States and foreign patents and pending patent applications (including those listed on Schedule 1 attached hereto) and any improvements thereto, including any and all utility models and design registrations granted for any inventions or improvements thereto, whether patented or unpatented; (ii) rights in any divisional, continuation, continuation-in-part, reexamination, or reissue thereof; (iii) rights to obtain patent or equivalent protection therein throughout the world; (iv) rights to claim priority based on the filing dates of applications under the Paris Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention and all other treaties of like purposes; and (v) rights to causes of action and remedies related thereto, including, without limitation, the right to sue, obtain relief, and recover any and all damages and profits, or seek injunctive relief, and any and all other remedies, for past, present, or future infringements or violations thereof, all in Assignee’s sole name;

(b) Copyrights. All right, title, and interest, in, to, and under the Respective IP Assets that comprise, consist of, or otherwise constitute any copyrights, including, without limitation, the following: (i) copyrights and works of authorship, whether or not copyrightable, and all registrations, applications for registration; (ii) renewals or renewal rights therein; (iii) rights to obtain registrations of such copyrights in the United States and throughout the world; (iv) rights to causes of action and remedies related thereto, including, without limitation, the right to sue, obtain relief, and recover any and all damages and profits, or seek injunctive relief, and any and all other remedies, for past, present, or future infringements or violations thereof, all in Assignee's sole name;

(c) Trademarks. All right, title, and interest in, to, and under the Respective IP Assets that comprise, consist of, or otherwise constitute any trademarks, including, without limitation, the following: (i) trademarks, service marks, brands, certification marks, logos, trade dress, trade names, and other similar indicia of source or origin (including the trademark listed on Schedule 1 attached hereto), together with the goodwill of the business that is symbolized thereby or associated therewith; (ii) renewals or renewal rights therein; (iii) rights to obtain registrations thereof throughout the world; (iv) rights to causes of action and remedies related thereto, including, without limitation, the right to sue, obtain relief, and recover any and all damages and profits, or seek injunctive relief, and any and all other remedies, for past, present, or future infringements or violations thereof, all in Assignee's sole name;

(d) Trade Secrets. All right, title, and interest in, to and under the Respective IP Assets that comprise, consist of, or otherwise constitute any trade secrets, including, without limitation, the following: (i) trade secrets, know-how, inventions (whether or not patentable), discoveries, improvements, technology, business and technical information, databases, data compilations and collections, tools, methods, processes, techniques, and other confidential and proprietary information and all rights therein; and (ii) rights to sue, obtain relief, and recover any and all damages and profits, or seek injunctive relief, and any and all other remedies, for past, present, or future misappropriations or violations thereof, all in Assignee's sole name; and

(e) Domain Names. All right, title, and interest in, to, and under the Internet domain names, social media accounts or user names (including "handles"), whether or not trademarks, all associated web addresses, URLs, websites and web pages, social media sites and pages, and all content and data thereon or relating thereto, whether or not copyrights (including, without limitation, the domain names and social media accounts listed on Schedule 1 attached hereto) (collectively, "Domain Names"), together with the goodwill of the business in connection with which the Domain Names have been used or are intended to be used.

3. Further Acts. Assignor agrees, without further consideration, to take or cause to be taken all actions and to do, or cause to be done, all things necessary, proper or advisable in the view of the Assignee to consummate and make effective the assignment contemplated herein and in the Agreement; including, without limitation, the execution of such documents, the filing of such instruments, and the taking of any such other actions as may be necessary or appropriate to vest all right, title, and interest in all of the Respective IP Assets in Assignee or its assignee and to consolidate, confirm, and record all aspects thereof.

4. Successors and Assigns. This IP Assignment shall be binding on and inure to the benefit of the Parties' respective successors and assigns.

5. Severability. In the event that any one or more of the provisions contained in this IP Assignment shall be invalid, illegal, or unenforceable in any respect for any reason, the validity, legality and enforceability of any such provision in every other respect and of the remaining provisions of this IP Assignment shall not be in any way impaired.

6. Governing Law. This IP Assignment shall be governed, construed and enforced in accordance with the laws of the State of Delaware without giving effect to the principles of conflicts of laws thereof.

7. Subject to Agreement. In the event of any conflict or other difference between the Agreement and this IP Assignment, the provisions of the Agreement shall govern and control.

8. Counterparts; Electronic Signatures and Records. The term "Electronic Signature" means (i) the signing Party's manual signature, converted by the signing Party to facsimile or industry-accepted digital form (such as a .pdf file) and received from the signing Party's customary email address, customary facsimile number, or other mutually agreed-upon authenticated source; or (ii) the signing Party's digital signature executed using a mutually agreed-upon digital signature service provider and digital signature process. This IP Assignment may be executed via manual signature or Electronic Signature. This IP Assignment may be so executed in counterparts, each of which will be considered an original and all such counterparts will be considered and constitute one and the same agreement. Each Party to this IP Assignment (a) agrees that it will be bound by its own Electronic Signature, (b) accepts the Electronic Signature of each other Party to this IP Assignment, and (c) agrees that such Electronic Signatures shall be the legal equivalent of manual signatures.


