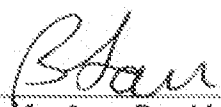

Accordingly, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor, a Delaware corporation having an address of 103 Foulk Road, Suite 202, Wilmington, Delaware 19803, for itself and its successors and assigns, hereby assigns to LANNETT COMPANY, INC., a Delaware corporation having an address of 1150 Northbrook Drive, Suite 155, Trevose, Pennsylvania 19053 ("Assignee"), its successors and assigns, all right, title and interest in and to the trademarks and trade names set forth on Schedule A attached hereto and made a part hereof, together with the goodwill associated therewith.

This Assignment of Trademarks and Trade Names includes the right to apply for registration of any and all of such trademarks and trade names in any and all jurisdictions where such registration is desired by Assignee, the right to renew any existing registrations, and the right to claim for any and all damages by reason of past infringement of any of such trademarks or trade names, with the right to sue for and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors and assigns. Assignor warrants to Assignee and its successors and assigns that, to the best of Assignor's knowledge, Assignor is the sole owner of such trademarks and trade names and that such trademarks and trade names and all right, title and interest thereto are not subject to any lien, claim, license, royalty arrangement or dispute.
