NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

June 15, 2022

This Notice of Release of Security Interest in Trademarks is made and effective as of June 15, 2022 (“Release of Security Interest”) by JPMORGAN CHASE BANK, N.A. (“JPMCB”), as collateral agent (in such capacity, the “Agent”), solely in its capacity as Agent for the Secured Parties (as defined in the Credit Agreement referred to below) under that certain Credit Agreement, dated as of July 18, 2017, by and among RYE PARENT CORP., a Delaware corporation (“Holdings”), PANERA BREAD COMPANY, a Delaware corporation (the “Parent Borrower”), the Lenders party thereto from time to time and JPMCB, as administrative agent and collateral agent (as amended, supplemented, modified or amended and restated from time to time prior to the date hereof, the “Credit Agreement”).

WHEREAS, (i) PARADISE BAKERY & CAFÉ, INC. (“PBCI”), a Delaware corporation, PANERA BREAD COMPANY (“PBC”), a Delaware corporation, PANERA LLC (“PANERA”), a Delaware limited liability company, and PUMPERNICKEL ASSOCIATES, LLC (“PA”), a Delaware limited liability company, entered into that certain Intellectual Property Security Agreement, dated as of July 18, 2017 (the “First IP Security Agreement”) and (ii) ABP CORPORATION, a Delaware corporation (together with PBCI, PBC, PANERA and PA, collectively, the “Grantors” and each a “Grantor”), entered into that certain Intellectual Property Security Agreement, dated as of March 5, 2018 (the “Second IP Security Agreement” and, together with the First IP Security Agreement, the “IP Security Agreements”), pursuant to which each Grantor party thereto pledged, assigned and granted to the Agent, on behalf of and for the benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in and to any and all Trademarks, including the trademarks listed under the applicable Reel/Frame No. on Schedule I hereto (collectively, the “Trademark Collateral”);

WHEREAS, the First IP Security Agreement was recorded with the United States Patent and Trademark Office on July 18, 2017 at Reel/Frame No. 6107/0818 and the Second IP Security Agreement was recorded with the United States Patent and Trademark Office on March 6, 2018 at Reel/Frame No. 6302/0032; and

WHEREAS, pursuant to the Payoff Letter, dated as of June 15, 2022, by and among Holdings, the Parent Borrower and the Agent, the Parent Borrower has requested and the Agent has agreed to procure, execute and deliver to the Parent Borrower, at the expense of the Parent Borrower, such documents confirming and carrying out the release and discharge of the Secured Parties’ security interest in the Trademark Collateral.

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby agree as follows:

1. Release. As of the date listed on the signature page hereto, the Agent hereby terminates, discharges, cancels and releases fully its security interests in and liens on the Trademark Collateral granted under each IP Security Agreement.

2. Further Assurances; Recordation. The Agent hereby agrees, at the Parent Borrower's expense, to execute such instruments and to take such other actions as the Parent Borrower may reasonably request to terminate the Agent's security interest in the relevant Trademark Collateral. The Agent hereby authorizes each Grantor and their successors, assigns or other legal representatives to file this Release of Security Interest with the United States Patent and Trademark Office, at the sole expense of the Parent Borrower, to evidence and effectuate the release and termination of the Agent's security interest in the Trademark Collateral.


3. Governing Law. This Release of Security Interest shall be construed in accordance with and governed by the laws of the State of New York.

4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the IP Security Agreements or the Credit Agreement, as applicable.


