**INTELLECTUAL PROPERTY ASSIGNMENT DEED**

between

**ARJO WIGGINS FINE PAPERS LIMITED (IN ADMINISTRATION)**  
as Assignor (acting by its Administrators)

**GEOFFREY PAUL ROWLEY, ALEXANDER IAIN FRASER AND THOMAS  
CAMPBELL MACLENNAN**

and

**AW BRANDING LIMITED**  
as the Assignee

THIS DEED OF ASSIGNMENT is made on 25/09/2019 between the following parties.

- (1) **ARJO WIGGINS FINE PAPERS LIMITED (IN ADMINISTRATION)**, a limited liability company incorporated in England and Wales with registered number 00961440, whose registered office is at FRP Advisory LLP, 2nd floor 110 Cannon Street, London EC4N 6EU (the "Assignor") acting by its administrators **Geoffrey Paul Rowley** of FRP Advisory LLP, 110 Cannon Street, London, EC4N 6EU, **Alexander Iain Fraser** of FRP Advisory LLP, Johnstone House, 52-54 Rose Street, Aberdeen AB10 1UD and **Thomas Campbell MacLennan** of FRP Advisory LLP, Apex 3, 95 Haymarket, Edinburgh EH12 5HD, as joint administrators of the Seller (the "Administrators") (each acting as agent of the Seller and without personal liability);
- (2) **THE ADMINISTRATORS**; and
- (3) **AW BRANDING LIMITED** a limited liability company incorporated in Scotland with registered number SC634260 Johnstone House, 52 - 54 Rose Street, Aberdeen, Scotland, AB10 1HA (the "Assignee").

#### WHEREAS

Pursuant to a business sale agreement dated on or around the date hereof made between the Assignor, the Administrators and the Assignee ("**Agreement**"), the Assignor has agreed to assign to the Assignee such right, title and interest (if any) as the Assignor may have in and to, with no title guarantee and subject to any encumbrances and third party rights that may attach to them, the Intellectual Property, as defined below.

**IT IS AGREED** as follows:

#### 1 Definitions

In this Deed:

"**Brands**" means the brands as set out in the Schedule.

"**Domain Names**" means the domain names as may be owned by the Assignor, including those set out in the Schedule.

"**Intellectual Property**" means the Patents, Trade Marks, trade names, service marks, trade secrets, right to sue for passing off, rights in confidential information, the Domain Names, copyright, software rights, database rights, design rights and registered designs, rights in know-how and other intellectual or industrial property rights and all similar rights of whatever nature (in each case, whether registered or unregistered and including applications for their protection or registration and all renewals or extensions of such rights or applications), whether vested, contingent or future, as may be owned by the Assignor and used in the Business (as defined in the Agreement), wherever existing.

"**IP Licence**" means the intellectual property licence dated 1 January 2004 between the Assignor and Arjowiggins Chartham Limited ("**AWC**") under which the Assignor granted a licence to use the Intellectual Property.

"**IP Licence Termination Notice**" means the notice issued by the Assignor to AWC dated on or around the date of this Deed terminating the IP Licence.

"Patents" means the patents and patent applications owned, used or held for use by the Assignor and used in the Business (as defined in the Agreement), including the patent registrations and applications set out in the Schedule.

"Trade Marks" means the registered and unregistered trade names, trade marks and service marks and applications for trade names, trade marks and service marks owned, used or held for use by the Assignor and used in the Business, including the trade mark registrations and applications set out in the Schedule.

## 2 Assignment

Pursuant and subject to the Agreement and for the consideration set out in the Agreement (the receipt of which the Assignor acknowledges) the Assignor HEREBY ASSIGNS to the Assignee such right, title and interest (if any) as the Assignor may have in and to, with no title guarantee and subject to any encumbrances and third party rights that may attach to them, and to the extent it is possible assign them in this Deed, the Intellectual Property, including but not limited to the Domain Names, the Trade Marks and the Patents and all and any rights in and to the Domain Names, Trade Marks and Patents, any common law rights thereto, the right to apply for the registration thereof, the right to sue for past infringements (including, without limitation, the right to take proceedings for passing off) and to retain any damages obtained as a result of such action and all the goodwill attaching to the Domain Names, Trade Marks and Patents together with the goodwill attaching to and associated with the Domain Names, Trade Marks and the Patents and of the business in which the Intellectual Property has been used by the Assignor TO HOLD the same unto the Assignee absolutely (the "Assigned Rights").

## 3 Further Assurance

3.1 For twelve (12) months after the date of this Deed, the Assignor and the Administrators, only while they remain as administrators of the Assignor must (at the cost of the Assignee) do and execute all lawful acts, deeds and documents within its or their respective powers as the Assignee may from time to time reasonably request and require (but on terms no more onerous to the Assignor and the Administrators than the terms of this Deed) for the purpose of giving effect to the provisions of this Deed including to vest the Domain Names, Trade Marks and Patents in the Assignee, and to have the Assignee recorded as the registered proprietor or applicant of the Domain Names, Trade Marks and the Patents on the relevant registers.

3.2 The Assignor appoints the Assignee to be its attorney in its name and on its behalf to execute documents, use the Assignor's name and do all things that are necessary for the Assignee to obtain for itself or its nominee the full benefit of the Assigned Rights. This power of attorney is given by way of security to secure the performance of the Assignor's obligations under this Deed and the proprietary interest of the Assignee in the Assigned Rights and so long as such obligations of the Assignor remain undischarged and the Assignee has such interest in the Assigned Rights, the power may be revoked by the Assignor acting reasonably.

## 4 Exclusion of liability

4.1 The Administrators incur no personal liability under, or because of, this Deed nor any related matter or claim arising and whether the claims are made in contract or tort by reference to any other right or remedy and in whatever jurisdiction or forum. In particular, the Administrators are not liable on any deed or document executed with a view to putting this Deed into effect, whether the deed or document so provides and the Administrators are entitled to have the deeds or documents amended to include an exclusion of personal liability in the above terms. The Administrators act as agents of the Assignor and have no personal liability by acting in that capacity.

4.2 The Assignee acknowledges that:

- (a) the Administrators' knowledge of the Intellectual Property is limited; and
- (b) the Assignee has no claim against the Assignor or the Administrators if items referred to in the Schedule are found to be incorrect.

4.3 The Assignee shall indemnify and keep indemnified the Assignor and the Administrators and each of them, to the fullest extent permitted by law, without deduction, set-off or counter claim, from and against all actions, proceedings, claims, demands, costs, expenses, penalties, loss and liabilities whatsoever incurred by the Assignor and/or the Administrators in connection with the Assignee's ownership and usage of the Intellectual Property after the Transfer Time (as defined in the Agreement).

## 5 IP Licence and IP Licence Termination Notice

5.1 The Assignee and the Administrators hereby acknowledge and agree that the IP Licence has been terminated upon the issuance of the IP Licence Termination Notice and that pursuant to the IP Licence and the IP Licence Termination Notice, AWC will not later than one week from the date of the IP Licence Termination Notice ("**Grace Period**") remove or obliterate the Intellectual Property from all materials used in connection with the goods in the possession, custody or control of AWC.

5.2 The Assignee and the Administrators hereby acknowledge and agree that AWC may continue to use the Intellectual Property after the expiry of the Grace Period solely for the purpose of completing any deliveries of goods, which make use of the Intellectual Property, provided that the orders for such goods were placed and accepted prior to the date of the IP Licence Termination Notice. The Assignee and the Administrators hereby agree that such use by AWC will not be deemed to be an infringement or compromise of the Assignee's rights in and to the Intellectual Property granted in this Deed and the Assignee and the Administrators hereby agree that no action will be taken against AWC or the Assignor in respect of such use.

## 6 Counterparts

This Deed may be executed in any number of counterparts and by the parties on separate counterparts (including by way of facsimile) but shall not be effective until each party has signed at least one counterpart. Each of such counterparts (when so executed) will constitute an original of this Deed and all of such counterparts will together constitute one and the same document.

## 7 Governing Law and Jurisdiction

This Deed and all matters (including, without limitation, any contractual or non-contractual obligation) arising from or connected with it are governed by, and will be construed in accordance with, English law. The courts of England shall have exclusive jurisdiction to settle any claim, dispute or matter of difference which may arise out of or in connection with this Deed (including without limitation claims for set-off or counterclaim).




