TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement"), dated as of January 28, 2019, is made by and between ECOPLY, LLC (successor by merger to Ecopy, Inc.) (the "Assignor") and NUANCE COMMUNICATIONS, INC. (the "Assignee").

WITNESSETH:

WHEREAS, the Assignor owns the trademarks listed in Schedule 1 hereto, together with all goodwill associated therewith, and all applications, registrations and renewals in connection therewith (the "Trademarks"); and

WHEREAS, the Assignor wishes to sell, assign, transfer and deliver to the Assignee, and the Assignee wishes to purchase and acquire from the Assignor, all of the Assignor's right, title and interest in, to and under the Trademarks.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound hereby, agree as follows:

Section 1. Assignment. The Assignor hereby sells, transfers, conveys, assigns and delivers to the Assignee, and the Assignee hereby purchases and accepts from the Assignor, all of the Assignor's right, title and interest in, to and under the Trademarks.

Section 2. Governing Law; Jurisdiction. This Agreement, and any and all proceedings commenced in connection with or relating to this Agreement, will be governed by, and construed and enforced in accordance with, the laws of the State of Delaware without regard of the laws that might otherwise govern under the applicable principles of conflict of laws of the State of Delaware (or any other jurisdiction). Each party agrees to submit to the exclusive jurisdiction of the Delaware Court of Chancery and any state appellate court therefrom within the State of Delaware (or, if the Delaware Court of Chancery declines to accept jurisdiction over a particular matter, any state or federal court within the State of Delaware), for the purpose of any action against a party hereto with respect to the subject matter of, or related to, this Agreement. Each party irrevocably waives any objection which it may now or hereafter have to the venue of any action arising out of or relating to this Agreement brought as provided in this subsection, and further irrevocably waives any claim that any such action brought in any such court has been brought in an inconvenient forum. To the extent a party has or may later acquire any immunity from jurisdiction of any court or from legal process with respect to itself or its property, such party hereby irrevocably waives such immunity under this subsection.

Section 3. Further Assurances. The Assignor shall cooperate, execute such documents, and do and perform such acts, at the Assignee's sole cost and expense, as may be reasonably requested by the Assignee to assist the Assignee in any such recordings or transfers to give effect to, document and record the assignment to the Assignee under this Assignment. The Assignor hereby requests the Commissioner of Patents and

Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record the Assignee as the assignee and owner of the Trademarks and to deliver to the Assignee, and to the Assignee's attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.

Section 4. Entire Agreement. This Agreement constitutes the entire agreement between the parties hereto relating to the subject matter hereof, and supersedes all prior negotiations, representations, understandings and agreements, both written and oral, between the parties hereto with respect to the subject matter of this Agreement.

Section 5. Counterparts. This Agreement may be executed in one or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. It will not be necessary in making proof of this Agreement or any counterpart hereof to produce or account for any of the other counterparts. Facsimile signatures or signatures received as a pdf attachment to electronic mail will be treated as original signatures for all purposes of this Agreement. This Agreement will become effective when, and only when, each party hereto will have received a counterpart signed by the other party hereto.
