Assignor covenants and agrees that it will execute all further documents and authorizations and take all other actions that may be necessary or required to effectuate the assignment and rights granted herein.

To be binding on the heirs, assigns, representatives and successors of the Assignor and extend to the successors, assigns and nominees of the Assignee.



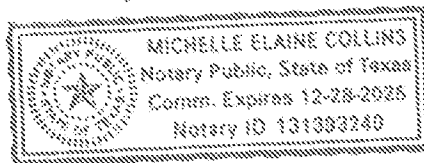

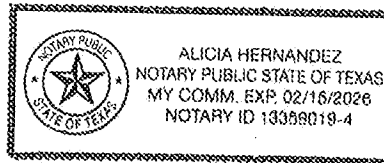
