UNITED STATES TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of the mutual promises set forth within this Trademark Assignment Agreement, and the original agreement between the parties, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:



Assignor confirms that it has assigned and hereby memorializes the assignment to Assignee of all of its rights, title and interest in and to the Trademarks, including common law rights, together with the good will of the business symbolized thereby and appurtenant thereto, including the right to all incoming royalties now or hereinafter due or payable with respect to the Trademarks, and the right to sue and recover any damages and profits, as well as any other remedies, for past, present and future infringements or misappropriations of the Trademarks.

Both Assignor and Assignee agree that this Trademark Assignment Agreement may be executed in one or more counterparts, each of which together shall constitute one and same original assignment document, and an electronically scanned or facsimile transmitted signature shall be deemed to be an original signature, and a true copy of this Trademark Assignment Agreement shall have the same legal effect as an original copy.
