**GRANT OF SECURITY INTEREST

This Grant of Security Interest has been given in conjunction with the security interest granted to the Administrative Agent under the Pledge Agreement, and the provisions of this grant are without prejudice to and in addition to the provisions of the Pledge Agreement, which are incorporated herein by this reference. This Grant of Security Interest and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Grant of Security Interest and the transactions contemplated hereby shall be governed by, and construed in accordance with, the law of the State of New York.
