ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

INGEO ACQUISITIONS, INC.

(Originally filed July 27, 2000)

COPY

1. The name of this corporation is InGeo Acquisitions, Inc.
2. Article I of this corporation's Articles of Incorporation is hereby deleted and restated in its entirety as follows:

ARTICLE I

The name of this corporation is InGeo Systems, Inc.

3. Except as set forth in the preceding paragraph, this corporation's Articles of Incorporation shall remain unchanged.
4. The foregoing amendment to the Articles of Incorporation was adopted by the corporation's shareholders effective as of July 31, 2000, in accordance with the requirements of Section 16-10a-1003 of the Utah Revised Business Corporation Act.
5. The corporation has one class of shares outstanding, designated as Common Stock, and 10,000,000 shares of Common Stock are outstanding. All of such shares were entitled to vote on the adoption of the foregoing amendment, with each share being entitled to one vote.
6. The number of votes entitled to be cast with respect to the foregoing amendment was 10,000,000. The number of votes cast in favor of the proposed amendment was 10,000,000; the number of votes cast against the proposed amendment was zero.
