NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Trademark Release”) is made as of July 5, 2022, by JPMORGAN CHASE BANK, N.A., a national banking association with an address at 500 Stanton Christiana Road, 1/NCC5, Newark, Delaware 19713, Attention: Account Manager, as Administrative Agent for the Secured Parties (in such capacity, together with any successors and permitted assigns, the “Assignee”), in favor of NEENAH, INC., a Delaware corporation, located at 3460 Preston Ridge Road, Suite 600, Alpharetta, Georgia 30005 (the “Assignor”).

W I T N E S S E T H:

WHEREAS, the Assignor and the Assignee are party to that certain Security Agreement (Personal Property), dated as of June 30, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which the Assignor, as collateral security for all of the Secured Obligations, pledged and assigned to the Assignee, and granted to the Assignee, for the benefit of the Secured Parties, a continuing security interest in the Collateral (as that term is defined in the Trademark Security Agreement), including without limitation the Trademarks set forth on Schedule 1 hereto;

WHEREAS, in furtherance of the Security Agreement, the Assignor executed and delivered that certain Trademark Security Agreement dated as of April 6, 2021 (the “Trademark Security Agreement”), which was duly recorded with the United States Patent and Trademark Office on April 21, 2021 at Reel 007266, Frame 0468;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Trademark Release, the Assignee hereby agrees as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement or the Trademark Security Agreement, as applicable.
2. Release. The Assignee, without recourse, representation or warranty of any kind, hereby releases, terminates, discharges, and cancels its security interest in and to the Collateral, including but not limited to the Trademarks listed on Schedule 1 attached hereto, if any. The Assignee, without recourse, representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement.
3. Recordation. The Assignee hereby authorizes and requests, at the Assignor’s sole cost and expense, that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Trademark Release.
4. Governing Law. This Trademark Release shall be governed by and construed in accordance with the applicable laws of the State of New York and the United States of America from time to time in effect.
