**AMENDED AND RESTATED
ASSIGNMENT OF TRADEMARKS**

This Amended and Restated Assignment of Trademarks (the “**Assignment**”) is made as of the 21st day of April, 2022, between NEW BATH TODAY INC., an Indiana corporation (the “**Assignor**”), and NEW BATH TODAY INC., an Indiana corporation (the “**Assignee**”).

BACKGROUND

A. Assignor is the owner of two U.S. trademarks, namely: (i) a standard character mark of “NEW BATH TODAY” in the Principal Register as Reg. No. 5,999,920; and (ii) a design mark of a stylized and shaded water droplet on the left side of the mark, followed by the words “NEW BATH TODAY” in stylized and capitalized letters on the right-hand side of the mark in the Principal Register as Reg. No. 5,999,921 (collectively, the “**Trademarks**”).

B. Both Trademarks are registered in Class 11 (for bathtubs, showers, and other bathroom items) and Class 37 (for installation of bathtubs, showers, and other bathroom items) and the Assignor desires to divide both registrations so that Assignor retains the Class 11 Trademarks as the parent registrations and the Assignee receives the Class 37 Trademarks as the child registrations.

C. Concurrently herewith, Assignor has filed Requests to Divide Registration of both Trademarks with the U.S. Patent and Trademark Office.


Now, therefore, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the recital provisions set forth above are incorporated into the body of this Assignment as if fully set forth herein, the parties agree as follows:

1. **Assignment.** Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor’s right, title, and interest in, to, and under the separated Class 37 Trademarks, together with the benefit of any use and the goodwill of said Trademarks.


2. **Construction.** All headings used in this Assignment are for convenience and reference only and have no significance in the interpretation or construction of this Assignment.
