The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Purchase Agreement, Bill of Sale and Assignment between the parties, effective November 1, 2021, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Trademarks. The representations, warranties, covenants, agreements, and indemnities contained in the Purchase Agreement, Bill of Sale and Assignment shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement, Bill of Sale and Assignment and the terms hereof, the terms of the Purchase Agreement, Bill of Sale and Assignment shall govern. This Assignment may be amended or modified only in a writing executed by the parties. This Assignment shall inure to the benefit of, and shall be binding upon, the parties, their respective successors and permitted assigns.
