ASSIGNMENT OF TRADEMARK RIGHTS

WHEREAS, ASSIGNEE, is desirous of acquiring the entire right, title and interest in and to the MARK;

NOW, THEREFORE, in consideration of the sum of One U.S. Dollar (\$1.00) and for other good and valuable consideration, the complete receipt and sufficiency of which are hereby acknowledged, ASSIGNOR agrees to assign, and hereby does assign, as of the EFFECTIVE DATE, all right, title, and interest in and to the MARK, together with all of the goodwill of the business symbolized thereby, and including the right by ASSIGNEE to sue for and keep for itself and its successors and assigns any recovery for all past infringements of said MARK.

This Assignment also includes any trademarks, and applications or registrations thereon excluded from Exhibit A that were among the IP assets intended to be transferred to Cattron North America, Inc. at closing but, for whatever reason, were not identified or disclosed at the time of closing. Thus, this Exhibit may be amended and added to, as necessary, following the date of closing.


